Vide letter under reference rates for Ghee refill pack 200 ml(ordinary) have been approved, subjected to submission of copy of the Agmark Licence required as per tender.

It is a matter of regret that inspite of repeated requests, your firm has failed to submit Agmark Licence and have informed us through email on 19.8.19 mentioning "we are unable to do the tender due to the problem while making the agmark licence." Our tender Terms & condition states that, "if successful bidder/supplier fails/denies to perform work after rate approval, the EMD may be forfeited and the firm may be blacklisted for future dealings by the management".
