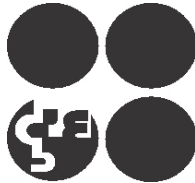

## SCHEDULE - I

### General Terms & Conditions of Tender

#### 1.0

**MP State Cooperative Dairy Federation is the state level apex institution in MP having six milk unions viz Bhopal, Indore ,Ujjain, Jabalpur, Gwalior and Sagar in the state of MP and works in the** brand name of “**SANCHI**” in milk and milk products intends to invites for rate contract of **Automatic** Tea and Coffee Vending Machine at affiliated milk unions located in the state of MP at approximate quantity in milk unions area is Bhopal-100 nos, Indore-100nos ,Ujjain-80nos, Jabalpur-100nos, Gwalior-80nos , BKDS (Sagar)-40nos in their marketing areas includes milk parlor, Milk booth, Milk Agency and some government offices.

The Tenderer (L2 and L3 ) other then L1 who is interested in supply of Tea and coffee vending machines on **approved rates of L1** may do so after written consent , If L1 does not have the capacity to supply.

The purchase order will be given by the concern milk unions for the supply of Tea and coffee vending machines.

#### 2.0 EARNEST MONEY DEPOSIT (EMD) :

- 2.1 The tenderer would be required to deposit of Rs 100000 /- (Rupees One Lakh only) online as Earnest Money. EMD submitted physically or by any means by any bidder shall not be entertained. Tenderers Registered in MP state MSME will be exempted from depositing EMD.
- 2.2 Any tender not accompanied with EMD shall be liable for rejection. Earnest Money Deposit of unsuccessful tenderers will be returned from the e procurement side automatically as per the MP e tender norms.
- 2.3 The EMD of the successful tenderer will be released only after **one year of rate validity period.**
- 2.4 No interest will be paid on the Earnest Money for the period during which (the EMD) lies in deposit with the Managing Director, MP State Cooperative Dairy Federation Ltd. Bhopal.
- 2.5 In the event, during the warranty period, if after sale services/ allied services by the successful tenderers are found dissatisfactory for any reasons thereof, then the EMD shall be forfeited by the **Managing director M P State Cooperative Dairy Federation Limited, Dugdha Bhavan, Habibganj, Bhopal**

#### 3.0 **BIDDER ELIGIBILITY CRITERIA.**

- 3.1 The tenderers should have PAN and GST number.

- 3.2 The Agency should have competence, infrastructure and expertise for installation and operations of Tea/Coffee/Soup vending machines and Rate contract of materials/consumables. The Agency should have adequate financial and technical competence and should be able to carry out the work.
- 3.3 Authorized distributor/franchise/Supplier of some renowned brand names like Nestle, Hindustan Unilever, Godrej, Cafe Coffee Day, Tata/Jiffy, Godrej, Gemini(B2C), Senso, Atlantis, Symbian, Tweak, Natural Zayaka/Magic hot and any other party who fulfill the tender requirement in the business of Tea/Coffee/Soup vending machines and Rate contract of minimum experience of **50 machines** in the trade will qualify.
- 3.4 Tenderer **Black listed** by any agency/ organization etc will not be eligible.
- 3.5 The Agency will have to open at least **one service center** at MP to rectify any technical problem of the machines and get it repaired on urgent basis with facility to repair/maintain in 24 Hours in City and 48 Hrs in rural areas if tender awarded.
- 3.6 **Bidder turnover of last year 2019-2020 must be minimum Rs 50 lakhs.**

#### **4.0 TENDER SUBMISSION :**

- 4.1 The tenderer will have to submit the technical bid papers online .
- 4.2 The **Financial bid shall mandatorily be submitted online only** (refer Schedule IV). In no case the financial bids would be entertained if submitted physically by any bidder.
- 4.3 The EMD will be opened online. Once it is found in order then only then the envelope containing the technical bid and scanned EMD copy of the concerning bidder shall be opened for further scrutiny.
- 4.4 The Financial bid of a bidder will be opened only when the individual tenderer / firm has successfully qualified the technical bid parameters / criteria.
- 4.5 The tenderers should clearly indicate the current contact mailing address, telephone, mobile, fax, e-mail, PAN and GST number. Any change in the address should immediately be communicated to the M P State Cooperative Dairy Federation Limited, Dugdha Bhavan, Habibganj, Bhopal.
- 4.6 The bidder should submit detailed technical specifications of the items /material being offered with related guarantee/warranty condition.
- 4.7 The bidder should submit copies of related testimonials proving his past experience of Rate contract Installation and commissioning in other organization during previous years.

- 4.8 Negligence / Carelessness on the part of tenderer in filling the tender form/quoted price shall cease his/her rights to withdraw from the tender once opened.
- 4.9 The tenderer shall submit the tender in the prescribed form only. Conditional tenders, in any case, are liable for outright rejection.
- 4.10 No Individual or firm shall be allowed to submit more than one tender under different names.
- 4.11 In the event if any firm that was functioning individually and for obvious reason has merged with another firm then in such cases the firm should submit copy of registration from competent authority ,only the mutual agreement between the two firms or companies will not be accepted.
- 4.12 Canvassing or offer of an advantage or any other inducement by any person with a view to influencing acceptance of a Tender will be an offence under laws of India. Such action will result in the rejection of the Tender, in addition to other punitive measures.
- 4.13 Negligence or carelessness on the part of the tenderer in filling the tender form / price / quote etc. shall not lend him / her any rights to withdraw from the tender once it is opened.
- 4.14 The tenderer shall submit the tender in the prescribed form only. Conditional tenders, in any case, are liable for outright rejection.
- 4.15 The tenderer cannot sublet or assign wholly or partially the approved Rate contract order to any other party/parties. In any case, if it is found so, then the assigned Rate contract order will immediately be cancelled and the party will be solely liable for black listing by MPCDF.
- 4.16 A copy of manufacturing license is to be attached with other technical bid documents of tender. The authorized dealers / channel partner etc. dealing with the item will have to attach a copy of authorization certificate of the concerning manufacturer.
- 4.17 The tenderer will have to provide all the details of his/her unit in the forms given at [Schedule-III](#).
- 4.18 The MD, M.P. State Cooperative Dairy Federation Limited, Dugdha Bhavan, Habibganj, Bhopal solely reserves the rights to accept or reject, wholly or partially, the tender / awarding purchase order without assigning any reasons thereof.

## **5.0 Prices and Validity period :**

- 5.1 The tenderer is required to quote price of Automatic Tea and Coffee Vending Machine with AMC of one year free and in continuation 3 years in the formula of (1+3=4years) with consumable parts for 01 year on FOR destination Rate contract basis as mentioned in purchase order.
- 5.2 The prices offered by the tenderer should be firm and free from all anticipated escalations.
- 5.3 Validity period with in **One year** for the date of tendering of rate approval of tender and may be extended for 06(SIX months).
- 5.4 The lowest rate so finalized will be inclusive of Machine cost at **FOR** basis with AMC cost for 3 years after warranty period of one year of the machine and consumable's parts for 01 year.
- 5.5 After successful opening the tender, rates will be finalized and Rate approved will be given by MPCDF.
- 5.6 Purchase order, payment and receipt of the Machine will be given by the milk unions located in the state of MP at Bhopal, Indore ,Ujjain, Jabalpur, Gwalior and Sagar or their authorized parlor agent/ booth/Agency/government agency etc.

## **6.0 MODE OF DISPATCH:**

- 6.1 Wharfage / demurrage etc. on account of incorrect or delayed dispatch of material of documents shall be the responsibility of supplier and shall be recovered from the bill.
- 6.2 Delivery schedule : However the machine should be supplied in the stipulated time which shall be within **One months** from the date of purchase order of the respective milk unions.
- 6.3 The supplier shall bear the insurance charges of the equipments during transit.

## **7.0 LIQUIDATED DAMAGES :**

- 7.1 If for any reason the successful tenderer refuses to accept purchase order / fails to Rate contract as per purchase order / backs out at a later date then the respective milk union(s) reserve the right to cancel the order and make purchases from other available alternate sources, at the risk and cost & expenses of the defaulting tenderer supplier and Rate contracting firm could be blacklisted for all future dealings. Also the EMD/Security deposit would be forfeited by MPCDF.
- 7.2 Once firm delivery schedule is fixed then it shall be strictly adhered to by the supplier. In case of supplies and services are not affected as per the schedules, the liquidated damages may be charged on the goods/services not so delivered as under.

- 7.3 After Rate contract of the machine, the supplier should ensure that the test trials will be done within 07 days of the Rate contract by the expert service engineer and ensure starts smooth operation by guiding and providing complete training and details of the operation to the operator / concern person.

## **8.0 MATERIAL DESCRIPTION:**

- 8.1 Specifications of the packaging machine with Automatic **Tea and Coffee Vending Machine** technology are given in Schedule-II.
- 8.2 The supplier has to install and give satisfactory trial run of the machines for the 50 ml, 100ml , 250 ml cup sizes at the dairy plant of the respective milk unions.
- 8.4 In case of defective items, the same shall have to be replaced by the party concerned at its own cost and risk and within stipulated time.
- 8.5 The supplier shall provide maintenance cost, functional description, operation and maintenance manual for each unit and consumables for one year and provide latest list of spare parts and its validity period.

## **9.0 INSPECTION:**



9.1 **All the materials are subject to inspection at our installation place before acceptance** after delivery . If machines are rejected due to any defect, deficiency transit damage or wrong Rate contract, the report of our inspector in this respect shall be final and no correspondence on the subject would be entertained. The rejected machines should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed off in auction and the proceeds, if any, less expenses shall be credited to the suppliers account.

**10.0 PAYMENT :**

Bill will be raised by the supplier on the basis of base price and GST separately but total of rate must be equal to the rate approved in the tender.

10.1 Payment shall be released on safe receipt and installation of machines at the site subject to acceptance after inspection by the concerned purchaser.

10.2 The payment of AMC will be done after every quarter subject to satisfactory report of purchaser.

**11.0 No deviation clause :**

No deviation will be accepted in any mandatory and terms conditions and specifications of the tender. In case any deviation is found after opening of technical bid and commercial bid tenderer will be debarred from the tender process and managing Director, MPCDF reserves the right to reject any or all tenders on the basis of any deviations contained in them.

**12.0 DISPUTE ARBITRATION & FINAL AUTHORITY:**

12.1 It should be clearly understood that in the event of a successful tenderer failing to accept or / and execute the Rate contract order, then decision of the Managing Director, MP state Cooperative Dairy Federation Ltd., Bhopal in this respect will be final and binding on the tenderer. For all disputes, the venue shall be at Bhopal, MP.

12.2 Successful tenderer failing to accept and execute the work order or any dispute arising thereof, then the content thereof shall be referred to the Arbitrator as per the Arbitration Act, 1996 and the award shall be at the discretion of the arbitrator.

12.3 For all disputes, the venue of the jurisdiction shall be at Bhopal, MP.
