**GENERAL TERMS AND CONDITIONS:**

The Indore Sahakari Dugdha Sangh Mydt., Indore invites e-tenders on behalf of Cattle Feed Factory, Pachama, Manglia , Bandol, Sagar and Shivpuri from suppliers for supply of the Herbal Feed Supplement as per our requirement according to our demand at CFF Pachama, Manglia, Bandol, Sagar and Shivpuri strictly in accordance with the detailed specifications given in the Schedule-II of the tender document.

1.0 **Tender submission:**

- 1.1 The tender should be submitted through e-tender as per the timetable given on the previous page.
- 1.2 Tenders should be submitted only by Online. The tenderers need to upload the purchase order of the Cattle Feed Plant under a reputed Co-Operative Milk union which is using the Herbal Feed Supplement (Galatagogue) as an ingredient of Cattle feed production.
- 1.3 The tenderers should clearly state in their offers the address for communication with their telephone number, Fax and E-mail etc. Any change in the address should immediately be notified to the General Manager Cattle Feed Factory, Manglia, Indore so that the correspondence thereafter may be made at their changed address.
- 1.4 The Empowered Committee will have the right to place the order for supply of Herbal Feed Supplement in full, partial or split in case the rates of more than one party are lowest & same, similar etc.
- 1.5 Tender period may be increased/decreased as per requirement.
- 1.6 This tender floated for one year, it can be extended for further one year if performance found satisfactory.

2.0 **EARNEST MONEY DEPOSIT**

- 2.1 The tenderers shall have to pay Earnest money of Rs. 1,00,000/- (Rupees One Lakh only) by Online. No interest will be paid on the earnest money. Submission of earnest money by any mode other than specified above shall not be accepted and the related tender shall not be eligible for consideration.
- 2.2 Earnest money deposit of unsuccessful tenderers will be returned within 30 days from the date of opening of the tender. The earnest money deposit of the successful tenderers shall be released on completion of successful supply of entire quantity allotted/ordered within the stipulated period and after receiving no objection certificate in this respect from Cattle Feed Factory, Manglia, Pachama , Bandol, Sagar and Shivpuri.

3.0 **PRICES:**

- 3.1 The prices should be quoted F.O.R. Destination Manglia / Pachama / Bandol/ Sagar and Shivpuri inclusive of packing forwarding, taxes, insurance & transportation charges etc.
- 3.2 'C' forms shall be provided as per rules.

#### 4.0 **MODE OF DESPATCH:**

4.1 On receiving orders from Cattle Feed Factory, Manglia/ Pachama / Bandol/ Sagar and Shivpuri the supply of material at Cattle Feed Plant, shall be the responsibility of the supplier, Quality inspection and rejection if any, shall be made at the Cattle Feed Plant Sites. The rejected quantity, if any, shall be lifted by the supplier at his cost.

The rejected material shall have to be lifted by the supplier within a week from the date of intimation from Cattle Feed Plant. The Cattle Feed Plant shall not be responsible for any deterioration due to delayed lifting of the rejected material by the supplier.

4.2 Herbal Feed Supplement to be suitably packed to prevent damages during transit and filled in thick polythene liner & woven HDPE Bag.

#### 5.0 **PAYMENT:**

5.1 The payment shall be made by Accounts payee Cheque / RTGS/NEFT only. The payment will be made after inspection.

5.2 No price escalation shall be given in contract period.

#### 6.0 **STATUS OF TENDER:**

6.1 The acceptance of the tender will be the sole right of the Empowered Committee which does not bind itself to accept a tender in whole or in part. Committee reserves the right to reject any or all the tenders or their part without assigning any reasons.

6.2 Negligence on the part of tender in filing the tender confers no right to withdraw the tender after it has been opened.

6.3 The Empowered committee has full right to stop the purchase of Herbal Feed Supplement (Galactagogue) at any time after review of its performance, feedback from milk producers or any other reason.

#### 7.0 **LIQUIDATED DAMAGES & PENALTIES:**

7.1 In the case of the non /late supply of the material, the urgent required quantity of the material shall be purchased from open market at available rate and the difference amount will be recovered from the a/c of the supplier.

7.2 Once the delivery dates are communicated by individual Cattle Feed Factory the same shall be strictly adhered to and this forms the essence of the contract. The supplies should be made as per given schedule. In case they are not followed then the Chief Executive Officer, Indore Sahakari Dugdha Sangh Mydt, Indore , the Chief Executive Officer, Bhopal Sahakari Dugdha Sangh Mydt, Bhopal , the Chief Executive Officer, Jabalpur Sahakari Dugdha Sangh Mydt, Jabalpur, the Chief Executive Officer, Gwalior Sahakari Dugdha Sangh Mydt and the Chief Executive Officer, Bundelkhand Sahakari Dugdha Sangh Mydt, reserves the right to make alternative purchases from open market and the difference of cost. if any, shall be recoverable from the defaulting supplier. In case the supplies are not affected as per schedules the liquidated damages may be charged on the goods not so delivered as under:-

#### **Duration of delay**

- a) One week
- b) Two weeks
- c) More than two weeks

#### **Penalty**

- 1% of the value of goods.
- 2% of the value of goods.
- 5% of the value of goods.

8.0 **INSPECTION:**

8.1 All the supplies are subject to inspection before acceptance. If goods are rejected due to defective or wrong supply then the rejected goods should be lifted from the CFF within seven days.

9.0 **WHARFAGE/DEMURRAGE:**

9.1 Wharfage /Demurrage etc. On account of incorrect or delayed dispatch of material or documents shall be the responsibility of supplier and shall be recovered from his bill.

10.0 **TERMINATION OF CONTRACT:-**

10.1 Any breach of the terms and conditions of contract shall tender the contract liable to termination/blacklisting of the firm, in addition to the payment of damage etc.

11.0 **SPECIFICATIONS: -**

11.01 Herbal Feed Supplement as per enclosed parameter.

12.0 **FINAL AUTHORITY:-**

12.1 It should be clearly understood that in the event of tenderer failing to accept and execute the supply order, decision of the Empowered Committee Shall be final.

12.2 At the time of submitting the tender, the tenderer shall give detailed information about their firm in the enclosed format annexed to form 'A'.

12.3 In matters of interpretation of the above clauses, the decision of the Chief Executive Officer, Indore Sahakari Dugdha Sangh Mydt. Indore for CFF Manglia , the Chief Executive Officer, Bhopal Sahakari Dugdha Sangh Mydt. Bhopal for CFF Pachama, the Chief Executive Officer, Bundelkhand Sahakari Dugdha Sangh Mydt for CFF Sagar, the Chief Executive Officer, Jabalpur Sahakari Dugdha Sangh Mydt for CFF Bandol and the Chief Executive Officer, Gwalior Sahakari Dugdha Sangh Mydt for CFF Shivpuri shall be final and binding on all concerned.

12.4 For all disputes the jurisdiction shall be Indore.

13.0 **ARBITRATION:**

In case of any dispute, if arises between the parties relating to any terms and conditions of the Tender/Agreement and/or regarding the Agreement/Tender before or after the filing of the Tender and/or execution of the Agreement, any party may refer the dispute to a Sole Arbitrator who will be the Managing Director of MPCDF or a person nominated by him/her whose decision and award shall be final and binding to both the parties. The arbitration proceedings shall be under and accordance with the provision of Arbitration and Conciliations Act 1996.
