1.00 GENERAL TERMS AND CONDITIONS

The Indore Shahkari Dugdh Sangh Mydt. Indore invites E-Tenders on behalf of Cattle Feed Factory, Pachama/Manglia/Sagar/Bandol & Shivpuri from suppliers/Producers of molasses as per requirement according to demand of the plant strictly in accordance with the detailed specifications given in the Schedule-II of the tender document to FOR destinations.

- 1.1 The bidders should clearly state their offers and the address for communication together with their E-mail address, telephone and Fax number. Any change in the address should immediately be notified to the General Manager, Cattle Feed Factory, Pachama/Manglia/Sagar/Bandol & Shivpuri so that the correspondence thereafter may be made at their changed address.
- 1.2 Obtaining all kind of permissions from state/central Govt. is a pre requisite for arranging molasses, and only such firms are eligible.
- 1.3 All quoted rates must be F.O.R. cattle feed plant Pachama/Manglia/Sagar/Bandol & Shivpuri destination at site inclusive of all expenses and taxes etc. and on the basis of Rs. per metric ton. No other taxes and expenses shall be considered.
- 1.4 Bidders shall specify in their offer the name of the state and the source of supply from where molasses shall be supplied/transported. The payment shall be made only to the approved bidder and not to any other agency.
- 1.5 Supply shall be as per schedule given. The successful bidder shall have to arrange for the permit from excise authorities on its own.

2.0 EARNEST MONEY DEPOSIT

2.1 The bidders shall have to pay Earnest money of Rs. 2,00,000/- (Rupees Two lakh only) online and scanned copy of it must be submitted.

3.0 **BID OFFER:-**

- 3.1 The prices quoted will be treated as F.O.R. destination, inclusive of all expenses and taxes and on basis of Rs. per MT.
- 3.2 Rate/unit must not under any circumstances be altered and rates must be entered in words and figures.

4.0 **SUPPLY SHEDULE:**

- 4. 1 The supply period shall be 60 days from the date of rate approved/ or as the instruction given by the relevant Cattle Feed Plant Manager. After last date of supply schedule the supply shall be accepted with penalty @ 1% per day on the quantity supplied late. For the quantity not supplied till the last date of schedule the short fall shall be arranged by way of risk purchase, in case the risk purchase is not made or partially made then short supply penalty of 5% of the short supplied quantity shall be imposed. The MPCDF reserves the absolute right of either making risk purchases in part or full and/or to impose 5% short supply penalty on the quantity remaining short supplied even after risk purchase.
- 4.2 On receiving orders from individual Cattle Feed Factory, the supply of molasses at different Cattle Feed Plants shall be the responsibility of the supplier. Quality inspection and rejection, if any shall be made at the Cattle Feed Plant Sites. The rejected quantity, if any, shall be immediately lifted by the supplier at his own cost. The Cattle Feed Plant shall not be responsible for any deterioration while lifting of the rejected material by the supplier.

5.0 **INSURANCE**:

5.1 Insurance shall be arranged by the Supplier at his cost. The Cattle Feed Factory, Pachama Manglia/Sagar/Bandol & Shivpuri will not be responsible for any transit damages and losses.

6.0 **<u>PAYMENT</u>**:

6.1 Our normal terms of payment are 80% payment on acceptance of material after inspection within a period of fifteen days after receipt. The payment shall be made through RTGS only. The remaining 20% Payment will be released after detailed quality testing report within thirty days.

7.0 **STATUS OF TENDER:**

7.1 The acceptance of the tender, and award of the purchase order will be the sole right of the MD, MPCDF who does not bind himself to accept a tender in whole or in a part. MPCDF reserves the right to reject any or all the tenders or their part without assigning any reasons thereof.

8.0 **INSPECTION:**

8.1 All material is subject to inspection before acceptance. The supplier should contact for the quality control report on 7th day of each supply made. If material rejected due to defective or wrong supply, the report of our laboratory in this respect shall be final and no correspondence on the subject would be entertained. The rejected material should be immediately lifted from the CFF.

- **1.** Material should be dark colored viscous syrupy liquid having characteristic odour. Sampling and testing will be done as per the procedure laid down by BIS.
- 2. Although no premium will be allowed proportionate deduction @ 1:1 ratio will be applied for each of the 2 indexes of quality mentioned above in case there is short fall over the given requirements.

10.0 **FINAL AUTHORITY:-**

- 10.1 It should be clearly understood that in the event of tenderer failing to accept and execute the supply order, decision of the E.C. for imposing penalty etc. shall be final and binding on the tender.
- 10.2 At the time of submitting the tender, the bidder shall supply detailed information about their activities in the enclosed format annexed to form A.
- 10.3 In matters of interpretation of the above clauses, the decision of the E.C. shall be final and binding on all concerned.
- 10.4 For all disputes the jurisdiction shall be Bhopal/Indore/Jabalpur/Gwalior/Sagar. No court outside Bhopal/Indore/Jabalpur/Gwalior/Sagar will have any jurisdiction.

11.0 **ARBITRATION:**

11.1 In case of any dispute, if arises between the parties relating to any terms and conditions of the Tender/Agreement before or after the filing of the Tender and/or execution of the Agreement, any party may refer the dispute to a Sole Arbitrator who will be the Managing Director of MPCDF whose decision and award shall be final and binding to both the parties. The arbitration proceedings shall be under and accordance with the provision of Arbitration and Conciliations Act 1996.
