### **1.0 Instruction to Bidder/Tenderer**

- (i) Bidder should read all terms & conditions of tender thoroughly before filling tender online.
- (ii) Scanned copy supporting document to be uploaded wherever required.
- (iii) Technical Bid, Form-A & Form-B shall be submitted online. Enclosed duly filled scanned copy to be uploaded in **pdf** format.
- (iv) Price bid shall be filled online only. Physical form of price bid will be rejected outrightly.

7.3 Octroi duty, if applicable at the destination, shall be borne by the supplier.

- 11.4 The CEO Indore Sahakari Dugdh Sangh Maryadit reserves the right to place order for sole requirement with any tenderer or split the orders among one or more tenderers.

#### **1. For CONDENSING COIL (MCC Chapda)**

- Condenser has 6 coils each coil have 12 M.S. heavy C-Class pipes of 2” dia.- 72 Pipe
- Length of pipes 21’6” and total 12 bend of 13” in each coil.
- Total length of one coil with bends is 259’ and coil should be deep galvanized.
- Each coil have ammonia valve of 2” with flange - 6 nos.
- 2 nos. of 1/2” air purging valve.
- Each coil have globe valve of 1” in liquid line- 6 nos.
- There should be two header one for gas and one for liquid line.
- Coil height – Minimum 65”, minimum 4” gap in between two pipes.
- Total length of four coils are  $259 \times 6 = 1554'$
- Condenser is to be provided with suitable liquid & gas headers and pipeline from NRV to condensed header to liquid receiver. And water cooling line with condensing line (Water sprinkler for cooling).
- Technical details are tentative and you may visit the site and take actual dimension of the complete coil before submitting offer.
- All required valves and flanges must be suitable for NH3 application and class 300 SA
- Test certificate of material from reputed authorized lab should be supplied before inspection by ISDS official.
- After assembling of coils all pipes must be deep galvanized for minimum thickness of 75-80 micron before dispatch at site and if required same will be inspected at supplier’s workshop by ISDS official.
- Supplier must have experience of similar installation and commissioning of NH3 refrigeration system/coil .They should furnish the proof of the same at the time of submission of their offer in technical bid.
