**2.0 Instruction to Bidder/Tenderer**

- (i) Bidder should read all terms & conditions of tender thoroughly before filling tender online.
- (ii) Bidder should deposit EMD through online only
- (iii) All required Technical Bid documents and EMD receipt shall be submitted physically only in sealed envelope subscribing tender number & tender reference at Indore Sahakari Dugdh Sangh Mydt, Indore (personal Section) on 13-08-19 , 2:30 pm.
- (iv) Price bid shall be filled online only. Physical form of price bid will be rejected out rightly.**
- (v) Form-A & Form-B enclosed duly filled scanned copy to be uploaded.

**3.0 EARNEST MONEY DEPOSIT/ SECURITY DEPOSIT**

- 3.1. All the tenders shall be required to pay Earnest Money as specified by us, in the mode of online only on [mptenders.gov.in](http://mptenders.gov.in), Submission of earnest money by any other mode than specified above shall not be acceptable and the related tender shall not be eligible for consideration.

- 3.2 Any tender which is not accompanied by Earnest Money Deposit is liable to be rejected. Earnest Money deposit of unsuccessful tenderer will be returned within 60 clear days from the date of opening of the tender. The earnest money deposit of the successful tender will be released on completion of supply/work as the case may be within the stipulated period.
- 3.3 No interest will be paid for the earnest money deposited.

#### **4.0 Duration of Contract**

This contract for GPS Tracking & Sensor system with necessary Accessories ,will be signed for 1 year between the Contractor & Chief Executive Officer, Indore Sahakari Dugdh Sangh. Further it can be extended for 1 year each upto 3 years on the basis of contractor's performance report.

#### **5.0 PRICE**

- 5.1 Price offered by the tenderers should be firm and free from all escalations. The prices offered should be valid at least for a period of 03 months from the date of approval of rates; we would communicate our rate approval within 45 days of opening of tender.
- 5.2 The tenderer should clearly specify whether rates quoted are inclusive / exclusive of GST. If exclusive rate of such items should be clearly indicated wherever possible.
- 5.3 The tenderer should quote rate F.O.R. destination.
- 5.4 Octroi duty, if applicable at the destination, shall be paid extra on all the dispatches made from the supplier's work/warehouses to the point of destination.
- 5.5 The Prices offered should be valid at least for a period of 90 days from the date of tendering the rates. we would communicate our rate approval within 45 days of opening of tender.
- 5.6 The lowest rate shall not be the only criteria for awarding the tender.
- 5.7 Comparison of the rate will be made on totality basis.

#### **6.0 PAYMENT**

- 6.1. 50% payment shall be released after receipt of material/system at site. Rest 40% payment shall be released after satisfactory functioning of the system for a month and proper training of staff to handle. Rest 10% will be released after receipt of Bank Guarantee equivalent to 10% of cost valid for one year.
- 6.2 Supplier has to submit the bank Guarantee of 10% of the purchase cost of the material for one year against performance after installation of Equipment otherwise balance 10% payment shall not be released to the supplier.

6.3 After completion of system installation, invoice has to be submitted in triplicate along with satisfactory performance report and training of concerned staff.

6.4 The Tenderer should ensure the completion of the work within 30 days from the date of awarding of the contract.

**Scope of work :-** Supply, installation, commissioning, repositioning and training of GPS instrument and uninterrupted link services through out the contract period .

## **7.0 GENERAL TERMS AND CONDITIONS**

7.1 The acceptance of the tender and award of the work order will be the sole right of the CEO Indore Sahakari Dugdh Sangh Maryadit, who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reason and no explanation can be demanded of the cause of rejection of the tender by any tenderer. If the tenderer fails to give services within the stipulated time mentioned in work order then they may be black-listed and EMD/SD also may be forfeited.

7.2 Negligence on the part of tenderer in filling the tender offers no right to withdraw the tender after it has been opened.

7.3 The tenderers should send their offers along with operational details etc., which will form the basis of their quotation and integral part thereof.

7.4 The CEO Indore Sahakari Dugdh Sangh Maryadit reserves the right to place order for sole requirement with any tenderer or split the orders among one or more tenderer.

7.5 The tenders received against the advertisement up to the specified time limit shall be considered. The Indore Sahakari Dugdh Sangh shall be bound to accept lowest rate tender.

- 7.6 Each tender should be accompanied with Income Tax Clearance Certificates, GST certificate without that, the tender may not be entertained.
- 7.7 The submission of a tender by a tenderer implies that he has read the notice and conditions of the tender and the terms and conditions of contract and has made himself aware of scope and specification of the services to be given and the destination where the services have to be given and satisfied himself regarding the quality and specifications of the services.
- 7.8 No person or firm is permitted to submit more than one tender under different names.
- 7.9 The conditional tenders are liable to be rejected.
- 7.10 The contractor shall not sublet the contract or assign to any other party or parties, the whole or any portion of the contract.

### **8.0 BLDDER ELIGIBILITY CRITERIA:**

- 8.1 Attested copy of valid GST certificate
- 8.2 Detailed Technical Specification of the items/material offered and guaranteed technical particulars and QAP.
- 8.3 Copies of balance sheet/P&L account of last three years as proof of turnover or CA certificate of balance sheet.
- 8.4 The bidder should have supplied more than 50 GPS QTY -3 pos or 100 GPS Qty In 1pos.
- 8.5 The bidder should have worked with minimum 2 cooperative companies or 2 govt./semi govt. companies (attach proof).
- 8.6 The bidder should have minimum 3 years experience in installation and maintenance of GPS system.
- 8.7 Authorization certificate from manufacturer for authorized supplier is must.

### **9.0 PROTECTION TO WORK:**

- 9.1 The supplier shall effectively protect at his own expense, such work, equipment or material as may be liable to damage, theft or tampering during erection / commissioning. Insurance charges etc. for the above shall be borne by supplier till handing over of complete installation to the ISDSM as per terms and conditions of contract.
- 9.2 The supplier shall arrange for safety and insurance etc. of his people employed for erection and installation work as per ESIC Act workman compensation and any other provision to meet statutory requirement of various Labour Act/Rules. In case of accident to any of the workers during the period of installation, ISDSM shall not bear any liability what so ever the entire responsibility primary and final in this respect will be that of supplier.

## **10.0 INSPECTION :**

10.1 All the materials are subject to inspection at our works before acceptance.

If goods are rejected due to defective or wrong supply, the report of our inspector in this respect shall be FINAL and no correspondence on the subject would be entertained. The rejected goods should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed of in auction and the proceeds, if any, less expenses credited to tenderer account.

10.2 Sample of the articles should be sent/ produced before the competent authority if asked for within 7 days or as mutually agreed.

## **11.0 LIQUIDATED DAMAGES**

11.1 The time period and the date of delivery of the material/services stipulated in the purchase/work order shall be deemed to be the essence of the contract. In case they are not followed or in case of delay in execution or non-execution of the order, the Dugdh Sangh reserves the right either to cancel the order and make alternative purchase/ arrange the completion of job from other sources, at the risk and cost & expensed of the defaulting supplier. In case the suppliers & services are not affected as per the schedules, the liquidated damages may be charged on the goods/ services not so delivered as under:(A) **Services**

## **12.0 TERMINATION OF CONTRACT**

12.1 Any act of omission on commission of a unit brings the Indore Sahakari Dugdh Sangh Maryadit, shall be competent to debar/black list the unit from further business with the Indore Sahakari Dugdh Sangh Maryadit.

## **13.0 CONSEQUENCES OF BREACH OF AGREEMENT**

13.1If the authorized person of the unit or a partner in the contract/tendering firm commit breach of any of the conditions of agreement it shall be lawful for the CEO, Indore Sahakari Dugdh Sangh Maryadit, to cancel the contract.

#### **14.0 DISPUTE ARBITRATION & FINAL AUTHORITY**

- 14.1 It should be clearly understood that in the event of tenderer failing to accept and execute the Purchase order, decision of the CEO, Indore Sahakari Dugdha Sangh Maryadit, in this respect will be final and binding on the tenderer.
- 14.2 At the time of submitting the tender, tenderer shall supply detailed information about their activities in the enclosed form.
- 14.3 For all the matters of dispute between supplier & Indore Sahakari Dugdh Sangh Maryadit, CHAIRMAN, ISDS shall be sole arbitrator for resolution of issuers & his decision shall be final and binding on both (Contractor & ISDS).
- 14.4 For all judicial issues the venue of jurisdiction shall be Indore only.

#### **15. MODE OF DESPATCH:**

- 15.1 The material to be supplied by successful tenderer shall be dispatched to the dairy under intimation to the purchaser. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit.
- 15.2 Wharf age / Demurrage etc. on account of incorrect or delayed dispatch of material of documents shall be the responsibility of supplier and shall be recovered from bill.
