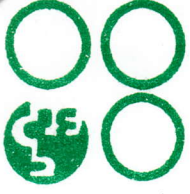

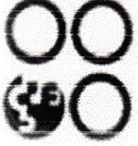

8.1 The tenderers should submit copy of IT return of last two years (2018-19 & 2019-20), Firm Registration, PAN Card & GST certificate duly sealed & signed.

8.3 The tenderers should submit copy of valid FASSI license (mandatory).

8.4 The bidder should be a manufacturer or authorized valid distributor of the manufacturer(certificate should be provided-mandatory)
