SCHEDULE - I

General Terms & Conditions to participate in tender and supply

Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain (USDSM), invites online tenders through M.P.tenders (www.mpetenders.gov.in) from Bonafide manufacturers for Supply/installation/commissioning of **Automatic Pouch Packing Machine for Milk Powder.** for its Ujjain Dairy Plant strictly in adherence to the detailed specifications given in the tender.

Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain reserves the rights to accept or reject any or all tenders, which in their opinion justify such actions, without further explanation to the tenderers.

1.0 DECLARATION:

The submission of a tender by a tenderer implies that he/she has read all terms and conditions of the tender and has made himself/herself aware of scope and specifications of the supplies to be made and the destination where the supplies have to be made and satisfied himself/herself regarding the quality and specifications of the articles.

2.0 TENDER SUBMISSION:

- 2.1 Not more than one tender shall be submitted by a Bidder/Firm for each items.
- 2.2 Tender documents consisting of specifications, schedule(s) etc. of supplies to be done, the condition of contract and other necessary documents will be opened for inspection online and issued for sale for payment of Rs.1,000/- to be paid online on or before scheduled date & time.
- 2.4 All tenders documents shall be submitted by the only online.
- 2.5 The tenderer(s) should clearly state in their offer the address, telephone, fax, e-mail, PAN and GST. Any change in the address should immediately be communicated to the Chief Executive Officer, Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain and correspondence thereafter will be made at the changed address.
- 2.6 Negligence on the part of tenderer in filling the tender form offers has no rights to withdraw the tender after it has been opened.
- 2.7 The acceptance of the tender and award of the purchase order will be the sole right of the Chief Executive Officer, Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain who does not bind himself to accept a tender in whole or in part or reject any or all the tenders received without assigning any reasons and no explanation can be demanded of the cause of rejection of the tender by any tenderer.
- 2.8 The tenderers should send their offers along with the specifications, necessary drawing, etc. which will form the basis of their quotation and integral part thereof.
- 2.9 The Chief Executive Officer, USDSM reserves the right to place order for whole requirement with any tenderer or split the orders among one or more tenderers or not to purchase at all any item even after rate approval.
- 2.10 Each tender should be accompanied with copy of PAN and GST numbers

- 2.11 The Tenderers should submit the tender in the prescribed form only. The conditional tenders will be rejected.
- 2.12 No person or firm is permitted to submit more than one tender under different names.
- 2.13 Each page of the tender and its enclosure should be signed at the bottom by the tenderer.
- 2.14 The tenderer cannot sublet the contract or assign to any other party or parties, the whole or any portion of the contract. If found so, the work order will be cancelled and party will be black-listed.
- 2.15 Manufacturers will be given preference. Copy of license is to be attached with tender for each item filled in, wholesalers dealing with the item will have to attach copy of authorization certificate of the manufacturer.
- 2.16 Tenderer shall fill all the details of the unit in the enclosed form in Schedule-III
- 2.17 Preference will given to manufacturers and those tenderers who have supplied above machineries to govt. organizations/co-operative dairies.
- 3.0 EARNEST MONEY DEPOSIT:
- 3.1 Earnest Money Deposit only online payment.

The Earnest Money Deposit of the successful tenderer will be released on completion of supply/successful implementation, testing and warranty (minimum one year) which covers maintenance. During the warranty period if services provided by the successful tenderer found not satisfactory then EMD will be forfeited by Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain.

- 3.3 No interest will be paid on the Earnest Money for the period during which (the EMD) lies in deposit with the UJJAIN SAHAKARI DUGDH SANGH MARYADIT, UJJAIN.
- 3.4 No Exemption will be allowed in EMD under any circumstances. Only MSME of state will be allowed only.
- 4.0 PRICES:
- 4.1 Rate should be quoted for supply, installation and commissioning, trial run and maintenance services during the warranty period which should be of minimum one year period on F.O.R. Basis.
- 4.2 If the tendering unit has any doubt as to the meaning of any of the conditions or the specifications before submitting the tender, set forth the particulars thereof, and submit them to the UJJAIN SAHAKARI DUGDH SANGH MARYADIT, UJJAIN in writing in order that such doubt may be removed.
- 4.3 The rates should be in figures as well as in words and no cuttings/overwriting in rates or material terms should be there in tender otherwise tender will be rejected.
- 4.4 Prices offered by the tenderers should be firm and free from all escalations. The prices offered should be valid at least for a period of 90 days from the date of tendering the rates. We would communicate our rate approval within 30 days of opening of tender.
- 4.5 The tenderer should quote rate F.O.R. destination.
- 4.7 The lowest rate shall not be the only criteria for awarding the tender.
- 4.8 Corrections, if any, in the tender should be noted over and signed at the places of each correction made.
- 5.0 MODE OF DESPATCH:

- 5.1 The material to be supplied by successful tendered shall be dispatched to the dairy plant under intimation to the purchaser. Depending upon the type of material, the supplier shall have to carry out proper packing/crating to avoid damage during transit.
- 5.2 Wharfage/Demurrage etc. on account of incorrect or delayed dispatch of material of documents shall be the responsibility of supplier and shall be recovered from bill.
- 5.3 Delivery schedule 30 days.

6.0 <u>LIQUIDATED DAMAGES:</u>

Once firm delivery date(s) are fixed, they shall be strictly adhered to. In case they are not followed, Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain/ respective milk unions reserves the right either to cancel the order and make alternative purchases from other sources, at the risk and cost & expenses of the defaulting Tenderer. In case the Tendered delay in supply of goods as per schedules, the liquidated damages will be charged as under:-

Sl. No.	Duration of delay	Liquidated Damages	
1.	Upto 15 days	1% cost of the unit.	
2.	Between 16 to 30 days	2% cost of the unit	
3.	Beyond 30 days	Upto 5% cost of the unit.	

- 6.2 If the tenderer fails to make supply as per purchase order without any valid reason, the order would be treated as cancelled and the firm may be blacklisted for future dealings and EMD/SD also would be forfeited by the management.
- 7.0 <u>BIDDER ELIGIBILITY CRITERIA:</u>
- 7.1 Attested copy of valid GST Registration Certificate and PAN number.
- 7.2 Detailed Technical Specification of the items/material offered and guaranteed technical particulars.
- 8.0 <u>MATERIAL/DESCRIPTION:</u>
- 8.1 Automatic Pouch Packing Machine for Milk Powder with Augar feeder and coding unit.
- 9.0 TERMS AND CONDITION & PROTECTION TO WORK:
- 9.1 The supplier shall effectively protect at his own expense, such work, equipment or material as may be liable to damage, theft or tampering during installation/commissioning. Insurance charges, etc. for the above shall be borne by the supplier till handing over of complete installation to Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain as per terms and conditions of contract.
- 9.2 The supplier shall arrange for safety and insurance, etc. of his people employed for erection and installation work as pert ESIC Act workman compensation and any other provision to meet statutory requirement of various Labour Act/Rules. In case of accident to any of the workers during the period of installation, Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain shall not bear any liability whatsoever the entire responsibility primary and final in this respect will be that of supplier.
- 9.3 All persons engaged by the tenderer shall be the contractor's own employee and they will claim no privileges from Dairy. The contractor will be directly responsible for the administration of the employees as regards general discipline and courteous behavior.
- 9.4 The Tenderer will not take out of the Dairy premises any article/material/equipment etc. without a Gate Pass issued by the authorized person of the Dairy.
- 9.5 The tenderer shall be responsible for all damages or losses to Dairy property by the tenderer himself or his staff and shall be liable to make payment.

- 9.6 The tenderer shall ensure that the personnel deployed by him are observed to adopt hygienic and safe act. Any act or practice which can cause or has the potential to cause financial loss to the Organization is liable for the financial penalty as imposed by the Dairy.
- 9.7 All personnel deployed by the tenderer will comply with the industrial norms/practice to maintain industrial discipline and peace and the responsibility for enforcing and ensuring the compliance of the same shall be directly of the supplier.
- 9.8 Tenderer shall comply with all statutory and/or administration requirement in connection with (i) personnel so deployed by the supplier in connection to the said work and (ii) their commercial arrangement.
- 9.9 Tenderer shall be solely responsible for any claim, damage, compensation, etc. that may become payable to any of the person or persons deployed by the supplier in connection with the work, in event of an accident or mishap resulting in any disability, injury or death of the person within or outside the premises of the Dairy. The Dairy shall not liable in any manner whatsoever either monetarily or otherwise for any accident or mishap as mentioned above.
- 9.10 Guarantee/warrantee certificates would be handed over after commissioning. Technical proper and sufficient operational training will be conducted by vendor.
- 9.11 In case of defective items, the same shall have to be replaced by the party concerned at its own cost and risk and within stipulated time.
- 9.12 During installation/commissioning, supplier shall incorporate/execute necessary minor modifications during the trial period for maximizing operational efficiency. The supplier should also execute minor modification as may be suggested by Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain without any extra cost.

10.0 <u>INSPECTION:</u>

10.1 All the materials are subject to inspection at our works before acceptance. If goods are rejected due to defective or wrong supply, the report of our inspector in this respect shall be FINAL and no correspondence on the subject would be entertained. The rejected goods should be removed from our premises by the tenderer within 15 days after receipt of our inspection report failing which the same shall be returned to the supplier at his risk and expenses or disposed off in auction and the proceeds, if any, less expenses credited to tenderer account.

11.0 PAYMENT:

11.1 70% payment shall be released after safe receipt of material/system at site. Balance 20% payment shall be released only after completion and successful trial run of machines and rest 10% payment will be released after submission of Bank Guarantee equal to 10% of order value towards performance guarantee of one year from the date of commissioning.

12.0 <u>TERMINATION OF CONTRACT:</u>

12.1 If any act of commission or omission of a unit under contract brings Ujjain Sahakari Dugdh Sangh Maryadit, Ujjain to dispute, the CEO, UJJAIN SAHAKARI DUGDH SANGH MARYADIT, UJJAIN shall be competent to debar/blacklist the unit from further business.

13.0 CONSEQUENCES OF BREACH OF AGREEMENT:

13.1 If the authorized persons of the unit or a partner in the contract/tendering firm commit breach of any of the conditions of agreement, it shall be lawful for the Chief Executive Officer, Ujjain Sahakari

Dugdh Sangh Maryadit Ujjain to cancel the contract and purchase or authorize to purchase stores at the risk and cost of the tenderer.

- 14.0 Arbitration: -
- 14.1 In any case, if a situation of dispute arises between the material / service provider and the milk union, the case can be presented to the Managing Director, MPCDF for resolution.
- 14.2 In case of non-resolution, action can be taken as per the provisions of the SPR slno 26.
- 15.0 SIGNING OF CONTRACT:
- 15.1 Successful tenderer shall enter into an agreement with UJJAIN SAHAKARI DUGDH SANGH MARYADIT, UJJAIN within 15 (Fifteen) days on receipt of letter of acceptance.
- 15.2 As the Contract has entered at Ujjain and head Office of USDS is as Ujjain hence the subject of jurisdiction at Ujjain

SCHEDULE - II TECHNICAL DETAILS/SPECIFICATIONS

1. Bagger Machine

- Equipped with:
- Delta PLC Controller
- Delta HMI (Pouch Screen panel)
- Pneumatic engage/dis-engage system with adjustable pressure for belt draw-off system.
- Pneumatically operated vertical sealing system best suitable for heat sealable laminates with stroke adjustable facilities.

2. Auto-print Mark Sensor Unit

- Independent assembly used for tracking mark sensor unit rear and forward.
- Print mark scanner used for scanning eye-mark for print registered bags.
- The minimum width of eye-mark should be 8mm and in contrast with print layout.

Note: The digital control also allows tracking the registration system directly from display. HMI main machine interface.

3. Web unwind Assembly.

- Motor carrying aluminum roller with rubber for peripheral rotation the web.
- Aluminum roller used to decrease the wait and rubber rings support the grip of web roll.
- Consistency in tension leads of lesser slippage of paper driving belts.
- The paper pulling torque decreases and increases the operational life of pulling belts appreciable.
- Limit switches to operate the motor and to ensure stop in case of film jam or at the end of film roll.

IMP – Even though the unwind works with two sensing devices, PLC also controls the unwind time for safety measures.

4. Bag Draw down mechanism

- Packaging material draw down with belts, driven separately by motor.
- Self aligning couplings
